Verification requires Fayetteville State University’s Office of Financial Aid to collect additional documentation to check the accuracy of the information you submitted on the FAFSA before a financial aid award can be made to you. **All verification documents must be attached to this form and returned to Fayetteville State University’s Office of Financial Aid within 5 days of receipt of the Missing Documents request and no later than the priority deadline of June 16, 2017.** Failure to submit ALL required verification documents will result in your financial aid award being delayed.

**C. 2015 Independent Student Income Verification**

**Tax Filers:** The instructions below apply to the student.

Instructions: Complete this section if you, the student and spouse, filed or will file a 2015 IRS income tax return(s). *The best way to verify income is by using the IRS Data Retrieval Tool (IRS DRT) that is part of FAFSA on the Web-Federal Student Aid application at [www.FAFSA.ed.gov](http://www.FAFSA.ed.gov). ## **INSTRUCTIONS FOR USING THE IRS DATA RETRIEVAL TOOL**

- 1) Access your 2017-2018 FAFSA application at [www.fafsa.ed.gov](http://www.fafsa.ed.gov)
- 2) Enter your FSA ID
- 3) Click on the Start 2017-2018 FAFSA button
- 4) Click the Next button to start entering your Student Demographic Information
- 5) To access the IRS Data Retrieval Tool
  - a. Click the Financial Information TAB
    - If you are a dependent student you will be directed to the Parent Financial Information section first and then to the Student Financial Information section.
- 6) Answer the IRS Data Retrieval Tool questions.
- 7) Click the option to Link To The IRS.
- 8) You will receive a message that you are leaving your FAFSA application and going to the IRS web site.
  - a. Click OK.
- 9) You must answer the following questions on the IRS Data Retrieval Site:
  - a. 2015 Filing Status- Single, Married Filing Jointly, Married Filing Separately, Head of Household
  - b. Exact address used on your 2015 Tax Return
  - c. Click submit
  - d. Your 2015 tax information will populate the screen
  - e. Click transfer my tax information into the FAFSA application
  - f. Click Transfer Now
    - **DO NOT** make any changes to the information transferred from the IRS Data Retrieval process. No further documentation is needed to verify 2015 IRS income tax return information that was transferred into the student's FAFSA using the IRS DRT if that information was not changed.
- 10) Add Wage information from your 2015 W-2 (s) in the Income Information section.
  - a. Click Next.
- 11) Enter your FSA ID
- 12) Click Agree.
- 13) Click Submit My FAFSA Now
