- 2) You must have a completed 2016-2017 FAFSA application on file in order to be considered for Summer Session I financial aid.
- 3) You must be in good academic standing with Fayetteville State University.
- 4) You must be enrolled at least half- time for SUMMER SESSION I in order to be eligible for financial aid. Half -time is considered 6 credit hours for undergraduate students and 3 credit hours for graduate students. **IN ORDER TO BE CONSIDERED FOR FEDERAL FINANCIAL AID FOR INTERSESSION, YOU MUST ENROLL IN BOTH INTERSESSION AND SUMMER I.** Ordinarily, only loans are available for summer session I if you have remaining loan eligibility from the academic year. You may contact The Office of Financial Aid to determine your eligibility.
